

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Overriding Veto of Resolution No. 12-467, "Adopting and Codifying Amendments
to Uniform Election Ordinance)**

**DEFEATED
RESOLUTION NO. 12-473**

1 **WHEREAS, the Legislative Council is vested with "all of the legislative powers vested in the Tohono**
2 **O'odham Nation" and is expressly vested with the power to "enact laws and ordinances**
3 **for conducting and regulating elections" (Constitution of the Tohono O'odham Nation,**
4 **Article V, Section 1; Article VI, Section 1 and subsection 1(g)); and**

5 **WHEREAS, on November 26, 2012 the Legislative Council approved Resolution No. 12-467,**
6 **"Adopting and Codifying Amendments to Uniform Election Ordinance"; and**

7 **WHEREAS, pursuant to Article VII, Section 5 of the Nation's Constitution,**
8 **Every law, ordinance, resolution or separate appropriation item passed by the Tohono**
9 **O'odham Council shall be presented to the chairman for his approval before it**
10 **becomes effective. If he approves, he shall sign it. But if he disapproves, he shall**
11 **return it to the Tohono O'odham Council within forty-eight (48) hours, with his**
12 **objections. If after consideration, it again passes the council by a majority of two-**
13 **thirds (2/3) of the votes cast, it shall become law and he shall sign it notwithstanding**
14 **his objections.**

15 **WHEREAS, on December 3, 2012, the Nation's Chairman vetoed Resolution No. 12-467; and**

16 **WHEREAS, pursuant to Article IX, Sections 2(B) and (C) of the Legislative Rules of the Tohono**
17 **O'odham Legislative Council, vetoed legislation shall be placed on the agenda of the**
18 **next legislative session and shall have priority over all items on the legislative agenda.**

19 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it overrides**
20 **the veto of Resolution No. 12-467, "Adopting and Codifying Amendments to Uniform**
21 **Election Ordinance."**

22 **The foregoing Resolution was defeated by the Tohono O'odham Legislative Council on the 03RD Day**
23 **of DECEMBER, 2012 at a meeting at which a quorum was present with a vote of 1,465.30 FOR;**
24 **1,315.30 AGAINST; 01 NOT VOTING; and -0- ABSENT, pursuant to the powers vested in the Council**
25 **by Article V, Section 1 and 2; Article VI, Section 1(g); Article X, Section 7; Article XIII; Article XIV;**
26 **Article XV; and Article VII, Section 5 of the Constitution of the Tohono O'odham Nation, adopted**
27 **by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
28 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
29 **18, 1934 (48 Stat. 984).**


