6		Nation ("Gaming Ordinance") was subsequently amended to authorize per capita
7		distribution payments in accordance with the Initiative (Legislative Council
8	:	Resolution No. 97-303); and
9	WHEREAS,	the Trust Agreement with Wells Fargo Bank requires that a listing of all minor
10		beneficiaries turning 18 that month be presented to the Tohono O'odham Legislative
11		Council to obtain approval to distribute the trust funds to these eligible minor
12		members as they are no longer restricted beneficiaries; and
13	WHEREAS,	the Tohono O'odham Legislative Council approved the minors identified on the
14	1	Monthly Age 18 Report for October 2012 who reached the age of 18 and are no longer
15		restricted from receiving their per capita payments in Resolution No. 12-389; and
16	WHEREAS,	the Nation's Enrollment Office has identified an incorrect spelling of name on a
17		member on the October 2012 listing; and
18	WHEREAS,	the Nation's Enrollment Office recommends that the name for the member be
19		amended on the October 2012 attached listing.
