

**LEGISLATIVE ORDER OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Certifying Elections of Committee Officers for Budget and Finance and Domestic Affairs
Committees)**

LEGISLATIVE ORDER NO. 12-480

1 WHEREAS, the Constitution of the Tohono O'odham Nation authorizes the Legislative Council to
2 "establish rules and procedures to regulate all meetings of the . . . standing
3 committees," (Constitution, Article VI, Section 1(a)); and

4 WHEREAS, effective November 29, 2012, Representative Evelyn Juan Manuel resigned her office
5 and Maria Ackerman succeeded her as a Legislative Council representative for Sells
6 District; and

7 WHEREAS, while in office, Representative Evelyn Juan Manuel served as chairperson of the
8 Budget and Finance and Domestic Affairs Committees and her resignation has created
9 vacancies in the two chairperson seats (Legislative Order No. 11-228 certifying
10 elections of Committee Officers for Legislative Council Standing Committees); and

11 WHEREAS, while the Legislative Rules of the Tohono O'odham Legislative Council, as amended,
12 does provide that "[w]hen a Legislative Council representative leaves office during his
13 or her term, any resulting vacancy on a Legislative Council committee shall be filled
14 by the representative's successor in office," this provision does not apply when filling
15 a committee officer vacancy (Legislative Rules, Article XII, Section 3(L)); and

16 WHEREAS, the Budget and Finance and Domestic Affairs Committees held caucuses to fill the
17 vacancies left by Representative Evelyn Juan Manuel.

18 NOW, THEREFORE, BE IT ORDERED that the Legislative Council certifies the election of the
19 following committee officers:

20 Budget and Finance Committee

21 Jana Montana - Chairperson

22 Olivia Villegas-Liston - Vice-Chairperson

23 Domestic Affairs Committee

24 Ethel Garcia - Chairperson

25 The foregoing Order was passed by the Tohono O'odham Legislative Council on the 03RD day of
26 DECEMBER, 2012 at a meeting at which a quorum was present with a vote of 2,780.60 FOR; -0-
27 AGAINST; -0- NOT VOTING; and -0- ABSENT, pursuant to the powers vested in the Council by Article
28 VI, Section 1 (a) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono
29 O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -
30 Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48
31 Stat. 984).
