

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving the Gu Achi District Fiscal Year 2013 Tower User Fees Budget in**  
**the amount of \$32,513.76)**

RESOLUTION NO. 12-482

- 1 **WHEREAS, the Tohono O'odham Legislative Council did convene on December 05, 2012 to address**  
2 **issues pertaining to the Nation; and**
- 3 **WHEREAS, the Gu Achi District Council passed Resolution #0808-244, approving the amended**  
4 **Management and Lease Agreement between the District, the Tohono O'odham Nation**  
5 **and the Tohono O'odham Utility Authority (TOUA); and**
- 6 **WHEREAS, the Tohono O'odham Nation Legislative Council passed Resolution #08-586,**  
7 ***"Approving a Management Agreement Between the Tohono O'odham Nation, Gu Achi***  
8 ***District and the Tohono O'odham Utility Authority for Jewek Mountain"; and***
- 9 **WHEREAS, as stated in Legislative Resolution #08-586 that *"the Nation, Gu Achi District (the***  
10 ***"District") and TOUA have negotiated a Management Agreement that allows and***  
11 ***directs TOUA to manage the telecommunications facilities on the top of Jewek***  
12 ***Mountain on behalf of the Nation and the District, and allows the Nation and the***  
13 ***District to obtain a stream of revenue from TOUA's leasing of space on the transmission***  
14 ***tower and the associated equipment building"; and***
- 15 **WHEREAS, the Gu Achi District has created a budget in the amount of \$32,513.76 from revenue**  
16 **from the tower user fees and was approved by the Gu Achi District Council (*Resolution***  
17 ***#1211-308*) for line items for Professional Services (*#7355*) and for Miscellaneous**  
18 ***(#7620)*; and**
- 19 **WHEREAS, the District's tower user fees budget was presented, reviewed and recommended for**  
20 **approval by the members of the Tohono O'odham Legislative Council's Budget and**  
21 **Finance Committee.**
- 22 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby**  
23 **approve Gu Achi District Fiscal Year 2013 Tower User Fees Budget of \$32,513,76 as**  
24 **attached hereto.**
- 25 **BE IT FINALLY RESOLVED that the Gu Achi District reserves the right to modify its Fiscal Year 2013**  
26 **tower user fees budget in accordance to the Tohono O'odham Nation's process set by**  
27 **the Tohono O'odham Legislative Council, but any amendments/modifications**  
28 **affecting the funds or funding levels of the Gu Achi District's Fiscal Year 2013 Tower**  
29 **User Fees Budget shall be approved by the Tohono O'odham Legislative Council.**
