4	Museum's Donations/Contributions account 001-0000-4851 for the use of the Tohono
5	O'odham Nation Cultural Center & Museum; and
6	WHEREAS, these funds are necessary for the Tohono O'odham Nation Cultural Center & Museum
7	to fulfill its mission through programs and capital expenditures; and
8	WHEREAS, the golf contribution in the amount of \$34,280.00 will be used for <i>Himdag Ki:</i> repository
9	completion regarding compact shelving; and
10	WHEREAS, the Cultural Preservation Committee and the Budget and Finance Committee have
11	reviewed the request to expend these funds.
12	NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby
13	approves the establishment of a new account and the expenditure of \$34,280.00 from
14	the Desert Diamond Casino's golf contribution by the Tohono O'odham Nation
15	Cultural Center & Museum, for the purchase of compact shelving in accordance with
16	the Cultural Center & Museum budget attached hereto.
17	BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the
18	Chairman and any designated official to expend and administer the budget, as

	attached, provided that any amendments affecting the funds of funding levels of the
20	budget shall be submitted for further prior approval by the Tohono O'odham
21	Legislative Council.
