8	money granted to an employee in addition to a regular pay; and						
9	WHEREAS, it is proposed that, as of November 29, 2012, employees shall receive \$500.00 as						
10	Christmas Bonus; and						
11	WHEREAS, the proposal was presented to the Legislative Budget and Finance Committee for						
12	consideration.						
13	NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it hereby						
14	approves a \$500.00 Christmas Bonus for employees of the Executive Branch, Judicial						
15	Branch and the Legislative Branch including all Appointed and Elected Officials of the						
16	three Branches, provided that employees hired on or after November 30, 2012 shall						
17	not be eligible to receive a Christmas Bonus.						
18	BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council that this payment be issued						
19	on the date of December 14, 2012.						
20	BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council appropriates						
21	from FY 2013 General Fund Surplus a total amount of \$841,346.10 in accordance with
