

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving the Gu Achi District Tower User Fees Carry Over Budget (FY2012 to FY2013)**  
**in the amount \$35,128.75)**

RESOLUTION NO. 12-496

- 1 **WHEREAS, the Tohono O'odham Legislative Council did convene on December 11, 2012 for a**  
2 **special session to address issues pertaining to the Nation; and**
- 3 **WHEREAS, the Gu Achi District Council passed Resolution #1206-216, approving FY2012 Tower**  
4 **User Fees Budget of \$112,613.94; and**
- 5 **WHEREAS, the Gu Achi District Council passed Resolution #0808-244, approving the amended**  
6 **Management and Lease Agreement between the District, the Tohono O'odham Nation**  
7 **and the Tohono O'odham Utility Authority (TOUA); and**
- 8 **WHEREAS, the Tohono O'odham Nation Legislative Council passed Resolution #08-586 "Approving**  
9 **a Management Agreement Between the Tohono O'odham Nation, Gu Achi District and**  
10 **the Tohono O'odham Utility Authority for Jewek Mountain"; and**
- 11 **WHEREAS, as stated in Legislative Resolution #08-586 that "the Nation, Gu Achi District (the**  
12 **"District") and TOUA have negotiated a Management Agreement that allows and**  
13 **directs TOUA to manage the telecommunications facilities on the top of Jewek**  
14 **Mountain on behalf of the Nation and the District, and allows the Nation and the**  
15 **District to obtain a stream of revenue from TOUA's leasing of space on the transmission**  
16 **tower and the associated equipment building."; and**
- 17 **WHEREAS, the Gu Achi District has created a budget in the amount of \$35,128.75 from carry over**  
18 **revenue of the tower user fees and was approved by the Gu Achi District Council**  
19 **(Resolution #1212-323) for line items for Supplies Office Equipment (#7005) and**  
20 **Professional Services (#7355); and**
- 21 **WHEREAS, the District's tower user fees carry over budget was presented, reviewed and**  
22 **recommended for approval by the members of the Tohono O'odham Legislative**  
23 **Council's Budget and Finance Committee.**
- 24 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby**  
25 **approve Gu Achi District Tower User Fees Carry Over Budget (FY2012 to FY2013) in the**  
26 **amount of \$35,128.75 as attached hereto.**
- 27 **BE IT FINALLY RESOLVED that the Gu Achi District may modify its tower user fees carry over**  
28 **budget in accordance to the Tohono O'odham Nation's process set by the Tohono**  
29 **O'odham Legislative Council, but any amendments affecting the funds or funding**


