## RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL (Appointing Barbara Atwood as a Judge Pro Tempore to the Tohono O'odham Judicial Court)

RESOLUTION NO. 12-497

1	WHEREAS, the Tohono O'odham Legislative Council is vested with the authority to appoint judges
2	to the Tohono O'odham Judicial Court (Constitution of the Tohono O'odham Nation,
3	Article VIII, Section 3); and
4	WHEREAS, the Legislative Council "may upon the recommendation of the chief judge appoint pro
5	tempore judges to the Judicial Court" (6 T.O.C. Chapter 1, Article 2, Section 1201); and
6	WHEREAS, the term of a judge pro tempore "shall be set forth in the resolution of the Legislative
7	Council appointing the judge, but in no case shall the term be longer than six years"
8	(6 T.O.C. Chapter 1, Article 2, Section 1204); and
9	WHEREAS, the chief judge has submitted Ms. Barbara Atwood's resume and a letter of support for
10	her as a judge pro tempore to the Tohono O'odham Judicial Court; and
11	WHEREAS, the Judiciary Committee, having legislative oversight of matters pertaining to the
12	Tohono O'odham Judicial Court, has interviewed Ms. Atwood and reviewed her resume
13	and the chief judge's letter of support.
14	NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it appoints
15	Ms. Barbara Atwood as a judge pro tempore to the Tohono O'odham Judicial Court for
16	a term beginning on January 1, 2013 and ending January 1, 2015.
