

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving Amendment #1 to the Sif-Oidak District FY 2013 Community Services  
Mining Royalties Budget to add a New Line Item for Christmas Bonuses in the  
amount of \$42,750.00)**

**RESOLUTION NO. 12-502**

1 **WHEREAS, the Sif-Oidak District Council, on July 26, 2012, passed Resolution No. SODC 12-092,**  
2 **“Approving the Sif-Oidak District FY 2013 Community Services Budget in the amount**  
3 **of \$541,000.00”; and**

4 **WHEREAS, the Tohono O’odham Legislative Council on September 11, 2012, passed Resolution No.**  
5 **12-352, “Approving the Sif-Oidak District FY 2013 Community Services Budget in the**  
6 **amount of \$541,000.00”; and**

7 **WHEREAS, the Sif-Oidak District Council, on December 15, 2012 enacted Resolution No. SODC 12-**  
8 **172, “Approving Amendment #1 to the Sif-Oidak District FY 2013 Community Services**  
9 **Mining Royalties Budget in the amount of \$42,750.00”; and**

10 **WHEREAS, the Amendment will add Line Item (624) Bonus to allow the Sif-Oidak District to give**  
11 **a Christmas Bonus to each of the District Staff, District Council/Alternates, Youth**  
12 **Council/Alternates; Committees/Alternates, Legislative Representatives and the**  
13 **Tohono O’odham Nation Youth Council Representatives/Alternates.**

14 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O’odham Legislative Council that it does**  
15 **hereby approve Amendment #1 to the Sif-Oidak District FY 2013 Community Services**  
16 **Mining Royalties Budget to add a New Line Item for Christmas Bonuses in the amount**  
17 **of \$42,750.00. (Attached hereto)**

18 **BE IT FURTHER RESOLVED that the funding amount of \$42,750.00 will be taken out of the Mining**  
19 **Funds held by the Tohono O’odham Nation Treasury on behalf of the Sif-Oidak District.**

20 **BE IT FURTHER RESOLVED that the funding amount increases the Community Services Mining**  
21 **Royalties Budget from \$541,000.00 to a new total of \$583,750.00.**

22 **BE IT FINALLY RESOLVED that in the event there should be any changes in the funding or funding**  
23 **levels that it shall be approved by the Tohono O’odham Legislative Council prior to any**  
24 **expenditures.**

25 **The foregoing Resolution was passed by the Tohono O’odham Legislative Council on the 19<sup>TH</sup> Day**  
26 **of DECEMBER, 2012 at a meeting at which a quorum was present with a vote of 2,780.60 FOR; -0-**  
27 **AGAINST; -0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by Article**  
28 **VI, Section 1 (d)(2) & (3) of the Constitution of the Tohono O’odham Nation, adopted by the Tohono**  
29 **O’odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**  
30 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**  
31 **Stat. 984).**




