13	Tohono O'odham Nation Youth Council Representatives/Alternates.
14	NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it does
15	hereby approve Amendment #1 to the Sif-Oidak District FY 2013 Community Services
16	Mining Royalties Budget to add a New Line Item for Christmas Bonuses in the amount
17	of \$42,750.00. (Attached hereto)
18	BE IT FURTHER RESOLVED that the funding amount of \$42,750.00 will be taken out of the Mining
19	Funds held by the Tohono O'odham Nation Treasury on behalf of the Sif-Oidak District.
20	BE IT FURTHER RESOLVED that the funding amount increases the Community Services Mining
21	Royalties Budget from \$541,000.00 to a new total of \$583,750.00.
22	BE IT FINALLY RESOLVED that in the event there should be any changes in the funding or funding
23	levels that it shall be approved by the Tohono O'odham Legislative Council prior to any
24	expenditures.

26	of <u>DECEMBER</u> , 2012 at a meeting at which a quorum was present with a vote of <u>2,780.60</u> FOR; <u>-0-</u>
