

**LEGISLATIVE ORDER OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving Tohono O'odham Nation 2013 Election Schedule)**

LEGISLATIVE ORDER NO. 12-503

1 **WHEREAS, the Constitution of the Tohono O'odham Nation vests the Legislative Council with the**  
2 **power to enact laws for conducting and regulating elections and the Council's decision**  
3 **"in all election matters . . . shall be final" (Constitution of the Tohono O'odham Nation,**  
4 **Article V, Section 1; Article VI, Section 1 and subsection 1(g); and Article X, Section 7);**


6 **WHEREAS, the Uniform Election Ordinance vests the Nation's Election Board with authority to**  
7 **conduct national elections, and the Board has adopted a "Tohono O'odham Nation**  
8 **2013 Election Schedule" that identifies significant election-related dates and**  
9 **deadlines for election to national and district offices, including dates and deadlines**  
10 **addressing the first election for Hia-Ced District officials (12 Tohono O'odham Code**  
11 **Chapter 1, Article IV); and**

12 **WHEREAS, although historically the Election Board has adopted and published schedules for**  
13 **conducting Nation's elections, 27 Tohono O'odham Code Chapter 1, Section 1108**  
14 **provides that the first election for Hia-Ced District officials shall be conducted in**  
15 **accordance with a schedule approved by the Legislative Council; and**

16 **WHEREAS, in order to ensure that the first election for Hia-Ced District officials is integrated into,**  
17 **and conducted as part of, the Nation's 2013 general election, it is in the Nation's best**  
18 **interest for the Legislative Council to approve the Tohono O'odham Nation 2013**  
19 **Election Schedule that the Election Board has adopted.**

20 **NOW, THEREFORE, BE IT ORDERED that, in accordance with 27 Tohono O'odham Code Chapter 1,**  
21 **Section 1108, the Tohono O'odham Legislative Council approves the Tohono O'odham**  
22 **Nation 2013 Election Schedule adopted by the Nation's Election Board; provided that**  
23 **the Board may exercise its existing authority under the Uniform Election Ordinance**  
24 **to adopt and publish schedules governing future elections.**

25 **The foregoing Order was passed by the Tohono O'odham Legislative Council on the 19<sup>TH</sup> day of**  
26 **DECEMBER, 2012 at a meeting at which a quorum was present with a vote of 2,360.20 FOR; -0-**  
27 **AGAINST; -0- NOT VOTING; and 420.40 [08] ABSENT, pursuant to the powers vested in the Council**  
28 **by Article V, Sections 1 and 2; Article VI, Section 1 (g); Article X, Section 7 of the Constitution of the**  
29 **Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and**  
30 **approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986,**  
31 **pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**
