

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving Sells District Economic Development Committee FY2013 Budget
for \$40,000.00)

RESOLUTION NO. 13-016

1 **WHEREAS, on July 20, 2010 Sells District Council approved resolution #SD-65-10 prohibiting**
2 **vending in the open areas located north and west of Tohono Plaza, and the area north**
3 **of Sells Services Station along the Sells Wash due to the vendors disregard in keeping**
4 **the area clean of trash, and properly disposing of grease and coals which have caused**
5 **fires; and**

6 **WHEREAS, the Sells District Economic Development Committee (EDC) an oversight committee of**
7 **the Districts businesses has developed a Vendor Policy which identifies a specific area**
8 **for vending in the area north of the Sells Service Station along the Sells Wash; and**

9 **WHEREAS, the Economic Development Committee in FY2012 with the passage of Resolution SD-**
10 **114-11 funded Phase One of the project to build ramada type structures and in the**
11 **future build upon those structures for vending spaces; and**

12 **WHEREAS, the Economic Development Committee has identified funds in the amount of**
13 **\$40,000.00 from the Morgan Stanley Smith Barney account titled Economic**
14 **Development to be utilized toward this next phase of development; and**

15 **WHEREAS, the proposed budget and its justification was reviewed and approved by the Sells**
16 **District Council with Resolution No. SD-103-12.**

17 **NOW, THEREFORE, BE IT RESOLVED THAT the Tohono O'odham Legislative Council approves the**
18 **FY2013 Sells District Economic Development Committee Budget in the amount of**
19 **\$40,000.00 from funding available in the Sells District account with Morgan Stanley**
20 **Smith Barney account titled Economic Development for the continued development**
21 **and operational costs of the vendor ramadas located north of the Sells Service Station.**

22 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the Sells**
23 **District Chairperson and any designated District official to expend and administer the**
24 **budget according to its justification as attached, provided that any**
25 **modifications/amendments affecting the funds or funding levels of the budget shall**
26 **be submitted for further prior approval by the Tohono O'odham Legislative Council.**

27 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 08TH Day**
28 **of JANUARY, 2013 at a meeting at which a quorum was present with a vote of 2,780.60 FOR; -0-**
29 **AGAINST; [02] NOT VOTING; and -0- ABSENT, pursuant to the powers vested in the Council by Article**
30 **VI, Section 1 (d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by the**
31 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
32 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
33 **18, 1934 (48 Stat. 984).**
