10	the Treasurer for the Tohono O'odham Nation.
11	NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby
12	approve the appointment of Mr. Frank F. Espino as Treasurer for the Tohono O'odham
13	Nation and Mr. Espino shall serve until replaced at the request of the chairperson of
14	the Tohono O'odham Nation.

16	of <u>JANUARY</u> , <u>2013</u> at a meeting at which a quorum was present with a vote of 1,942.55 FOR; 838.05
