

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2013 Legislative Branch Budget Modification No. 2/Amendment No. 2)

RESOLUTION NO. 13-019

1 WHEREAS, the Legislative Council is authorized "to manage any funds within the exclusive
2 control of the Tohono O'odham Nation . . . and to appropriate these funds for the
3 benefit of the nation and its members" provided that "[a]ll expenditures of these funds
4 shall be pursuant to appropriations or budgets" authorized by resolution or
5 ordinance (Constitution of the Tohono O'odham Nation, Article VI, Section 1(d)(2)); and

6 WHEREAS, the Legislative Branch FY 2013 budget was approved by Resolution No. 12-209; and

7 WHEREAS, the Legislative Branch administration has prepared and submitted for review and
8 approval its FY 2013 Budget Modification No. 2/Amendment No. 2 in the amount of
9 \$13,000.00 to include new line items #7430 RM Grounds to cover the cost of
10 landscaping projects for the Legislative Branch; and

11 WHEREAS, the salary adjustment for Legislative Assistant will be funding from Salary Savings of
12 3 months from the two vacant transcriber positions; and


13 WHEREAS, the FY 2013 Legislative Branch Budget Amendment No. 2/Modification No. 2 has been
14 reviewed by the Budget and Finance Committee and recommends approval.

15 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves
16 the FY 2013 Legislative Branch Budget Modification No. 2/ Amendment No. 2, including
17 new line item #7430 RM Grounds as attached hereto, which does not change the overall
18 base budget due to salary saving. Retroactive to October 1, 2012 for salary adjustment.

19 BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham
20 Nation Legislative Council Chairman and Vice-Chairman are authorized to administer
21 the attached budget, provided however, that any amendments affecting these funds
22 or funding levels budgeted shall be submitted for prior approval by the Tohono
23 O'odham Legislative Council.

24 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 09TH Day
25 of JANUARY, 2013 at a meeting at which a quorum was present with a vote of 2,780.60 FOR; -0-
26 AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by Article
27 VI, Section 1 (d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono
28 O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -
29 Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48
30 Stat. 984).
