RESOLUTION NO. 13-021

1 **WHEREAS, the Arizona Department of Economic Security entered into an intergovernmental**
2 **agreement (IGA) with the Tohono O'odham Nation to provide the Nation with funds for**
3 **specific Workforce Investment Act (WIA) employment and training programs operated**
4 **by the Education Department's One Stop Division; and**

5 **WHEREAS, the IGA was approved by this Legislative Council Resolution #12-273; and**

6 **WHEREAS, pursuant to the IGA, the Arizona Department of Economic Security has allocated funds**
7 **to the Nation for FY2012 in the amount of \$243,436.00 for the period beginning April**
8 **1, 2011 to June 30, 2013; and**

9 **WHEREAS, the One Stop Division has expended funds in FY12 leaving a total amount of**
10 **\$126,068.60 to be carried forward into FY13; and**

11 **WHEREAS, the One Stop Division has seven (7) program budgets and requests to expend these**
12 **budgets per attached budgets; and these budgets as identified in the following table;**




