6		judges from office for criminal conduct, gross neglect of duty, and other grounds
7		subject to a reasonable cause determination by the Judiciary Committee and a final
8		determination by the Legislative Council (6 T.O.C. Chapter 4, Suspension of Judges)

10	WHEREAS.	if the Legislative Judiciary Committee finds reasonable cause exists for an offense
11	,	alleged in a suspension statement filed against a Nation's judge, the Legislative
12		Council is required to conduct a judicial suspension hearing and may adopt
13		procedures for that purpose (6 T.O.C. Chapter 4, Section 4105); and
14	WHEREAS.	the Judiciary Committee has found reasonable cause to believe Judge Michael T
15	,	Telep, Jr. has committed offenses alleged in a suspension statement filed by the
16		Nation's chief judge, and the Rules Committee recommends holding the judicial
