

**LEGISLATIVE ORDER OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Recognizing the San Lucy District Council Appointment of Diana Manuel as**  
**Alternate to Legislative Representative Lorraine Eiler)**

LEGISLATIVE ORDER NO. 13-028

1 WHEREAS, the Constitution of the Tohono O'odham Nation empowers the Legislative Council to  
2 "enact laws and ordinances for conducting and regulating elections" and provides  
3 that the "decision of the Tohono O'odham Council in all election matters, including  
4 the eligibility and qualifications of candidates, shall be final" (Constitution, Article VI,  
5 Section 1(g) and Article X, Section 7); and

6 WHEREAS, during the May 2009 general election, Lorraine Eiler was elected as Legislative Council  
7 representative and Charlotte Cadavas her alternate for the San Lucy District; and

8 WHEREAS, on June 9, 2009, alternate Charlotte Cadavas submitted her letter of resignation to  
9 then Legislative Council chairman Verlon Jose, leaving the alternate position for San  
10 Lucy District vacant; and

11 WHEREAS, on January 23, 2013, the San Lucy District Council appointed Diana Manuel to serve as  
12 Representative Lorraine Eiler's alternate on the Legislative Council (San Lucy District  
13 Council Resolution No. SL-01-05-13); and

14 WHEREAS, the Legislative Council, as a means of ensuring that each district is fully represented  
15 on the Legislative Council, has recognized district council appointments to vacant  
16 alternate seats in instances where vacancies have occurred outside of provisions  
17 expressly outlined in the Uniform Election Ordinance for filling vacancies.

18 NOW, THEREFORE, BE IT ORDERED by the Tohono O'odham Legislative Council that it recognizes  
19 the San Lucy District Council appointment of Diana Manuel to serve as alternate to  
20 Legislative Council Representative Lorraine Eiler when Representative Lorraine Eiler  
21 is unable to attend a Legislative Council session

22 The foregoing Order was passed by the Tohono O'odham Legislative Council on the 28<sup>TH</sup> day of  
23 JANUARY, 2013 at a meeting at which a quorum was present with a vote of 2,568.70 FOR; -0-  
24 AGAINST; -0- NOT VOTING; and 211.90 [04] ABSENT, pursuant to the powers vested in the Council  
25 by Article VI, Section 1 (g); Article X, Section 7; and Article XII, Section 1 of the Constitution of the  
26 Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and  
27 approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986,  
28 pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
