#### **RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL** (Recognition of Relinquishment from membership in the Tohono O'odham Nation for the month of February 2013)

## RESOLUTION NO. 13-030

1	WHEREAS, Article VI, Section 1(h) of the Constitution of the Tohono O'odham Nation vests the
2	Tohono O'odham Legislative Council with the power to "enact laws and ordinances
3	governing the enrollment and adoption of members and the relinquishment and loss
4	of membership"; and
5	WHEREAS, in accordance with the Tohono O'odham Nation's Enrollment Ordinance, Ordinance
6	No. 05-81, as amended, the Enrollment Committee has received a written statement
7	from 1 tribal member who has expressed an intent to relinquish membership with the
8	Tohono O'odham Nation and a member identified in the February 2013
9	Relinquishment List, which is incorporated by this reference; and
10	WHEREAS, pursuant to Article IX, Section 1 of the Enrollment Ordinance,
11	<u>A member of the Nation may relinquish his membership in the Nation by submitting</u>
12	<u>a written statement clearly expressing an intent to relinquish his membership to the</u>
13	<u>Conncil, a copy of which must be served on the committee. The written statement</u>
14	<u>must be signed by the person wishing to relinquish his membership or, if a minor or</u>
15	incompetent, by the parent(s), guardian or other person legally authorized to act on
16	his behalf. Relinquishment does not require the approval of the Council, but is
17	effective upon receipt of the statement by the Council and cannot be subsequently
18	denied. Upon recognition by the Council that the individual has renounced his
19	membership, his name shall be deleted from the membership roll.
20	NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby
21	recognizes that the individual identified in the February 2013 Relinquishment List
22	have relinquished their membership in the Tohono O'odham Nation and orders the
23	removal of their names from the Nation's membership roll.
28 29	The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the $04^{TH}$ Day of <u>FEBRUARY, 2013</u> at a meeting at which a quorum was present with a vote of <u>2,780.60</u> FOR; <u>-0-</u> AGAINST; <u>-0-</u> NOT VOTING; and[ <u>04</u> ]ABSENT, pursuant to the powers vested in the Council by Article VI, Section 1 ( <u>h</u> ) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
