10		timely exercised its option to renew the Business Lease for the Water Well Sites for a
11		period of twenty-five years; and
12	WHEREAS,	pursuant to Section 7 of the Business Lease for the Water Well Sites, Cyprus and the
13		Nation entered into negotiations to determine a mutually agreeable fair purchase
14		price per acre foot of water extracted from the Property by Cyprus from the water wells
15	:	subject to the lease; and
16	WHEREAS,	the parties have reached a mutually acceptable fair purchase price of \$250.00 per acre
17	1	foot of water extracted from the Property for the term of the renewal; and
18	WHEREAS,	the Agricultural and Natural Resources Committee have reviewed Addendum No. 1 to
19	1	the Business Lease (Water Well Sites) and recommend approval.
