

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Confirming the Appointment of Ms. Cheryl Lopez to the Tohono O'odham Nursing
Care Authority Board of Directors)**

RESOLUTION NO. 13-045

1 **WHEREAS, the Tohono O'odham Legislative Council is vested with the power to "provide for,**
2 **appoint, or provide for the appointment of, and prescribe the duties and powers of**
3 **committees, boards, officers, and agents;..." (Article VI, Section 1(b) Constitution of the**
4 **Tohono O'odham Nation); and**

5 **WHEREAS, the Legislative Council has enacted and subsequently amended the "Charter of the**
6 **Tohono O'odham Nursing Care Authority," (Charter) which established a Board of**
7 **Directors (Board) which shall have ultimate accountability for the management of the**
8 **Tohono O'odham Nursing Care Authority (Article IV §(4.1); and**

9 **WHEREAS, the Charter provides: "All terms shall be for four years, expiring on the 30th day of**
10 **October of the fourth year. No term shall expire except on the 30th day of October,**
11 **notwithstanding the month in which the Legislative Council confirms the**
12 **appointment" or until their successors are qualified and confirmed (Article IV §(4.2.4);**
13 **and**

14 **WHEREAS, the Charter provides that the Chairman of the Nation shall nominate and the**
15 **Legislative Council shall confirm Directors to the Tohono O'odham Nursing Care**
16 **Authority Board (Article IV §(4.2.3); and**

17 **WHEREAS, the Chairman of the Nation has researched, identified and determined that Ms. Cheryl**
18 **Lopez is both willing and qualified to serve as one of the Directors to the Tohono**
19 **O'odham Nursing Care Authority Board; and**

20 **WHEREAS, the Chairman of the Nation does hereby nominate for appointment, Ms. Cheryl Lopez**
21 **to the Tohono O'odham Nursing Care Authority Board; and**

22 **WHEREAS, the Legislative Health & Human Services Committee and Legislative Rules Committee**
23 **have both reviewed the Chairman's nomination.**

24 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby accept**
25 **and approve the confirmation of Ms. Cheryl Lopez to the Tohono O'odham Nursing**
26 **Care Authority Board of Directors for a four year term effective October 31, 2011 and**
27 **ending on October 30, 2015, provided that she shall continue to serve until replaced**
28 **by her successor.**
