5	WHEREAS,	the Legislative Council has enacted and subsequently amended the "Charter of the				
6		Tohono O'odham Nursing Care Authority," (Charter) which established a Board of				
7		Directors (Board) which shall have ultimate accountability for the management of the				
8		Tohono O'odham Nursing Care Authority (Article IV §(4.1); and				
9	WHEREAS,	the Charter provides: "All terms shall be for four years, expiring on the $30^{\text{th}}$ day of October of				
10		the fourth year. No term shall expire except on the 30th day of October, notwithstanding the				
11		month in which the Legislative Council confirms the appointment" or until their successors				
12		are qualified and confirmed (Article IV §(4.2.4); and				
13	WHEREAS,	the Charter provides that the Chairman of the Nation shall nominate and the Legislative				
14		Council shall confirm Directors to the Tohono O'odham Nursing Care Authority Board (Article				
15		IV §(4.2.3); and				
16	WHEREAS,	the Chairman of the Nation has researched, identified and determined that Ms. Geneva				
17		Ramon is both willing and qualified to serve as one of the Directors to the Tohono O'odham				
18		Nursing Care Authority Board; and				
19	WHEREAS,	the Chairman of the Nation does hereby nominate for appointment, Ms. Geneva Ramon to the				
20		Tohono O'odham Nursing Care Authority Board; and				
21	WHEREAS,	The Legislative Health & Human Services Committee and Legislative Rules Committee have				
22	II	both reviewed the Chairman's nomination.				
23	NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby accept and					
24		approve the confirmation of Ms. Geneva Ramon to the Tohono O'odham Nursing Care				
25		Authority Board of Directors for a four year term effective October 31, 2011 and ending on				
26		October 30, 2015, to replace Madeline Sakiestewa, provided that she shall continue to				
27	ļi.	serve until replaced by her successor.
