

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Confirming the Re-appointment of Ms. Malinda Folson to the Tohono O'odham  
Nursing Care Authority Board of Directors)**

**RESOLUTION NO. 13-049**

1 **WHEREAS, the Tohono O'odham Legislative Council is vested with the power to "provide for,**  
2 **appoint, or provide for the appointment of, and prescribe the duties and powers of**  
3 **committees, boards, officers, and agents;..." (Article VI, Section 1(b) Constitution of the**  
4 **Tohono O'odham Nation); and**

5 **WHEREAS, the Legislative Council has enacted and subsequently amended the "Charter of the**  
6 **Tohono O'odham Nursing Care Authority," (Charter) which established a Board of**  
7 **Directors (Board) which shall have ultimate accountability for the management of the**  
8 **Tohono O'odham Nursing Care Authority (Article IV §(4.1); and**

9 **WHEREAS, the Charter provides: "All terms shall be for four years, expiring on the 30<sup>th</sup> day of**  
10 **October of the fourth year. No term shall expire except on the 30<sup>th</sup> day of October,**  
11 **notwithstanding the month in which the Legislative Council confirms the**  
12 **appointment" or until their successors are qualified and confirmed (Article IV §(4.2.4);**  
13 **and**

14 **WHEREAS, the Charter provides that the Chairman of the Nation shall nominate and the**  
15 **Legislative Council shall confirm Directors to the Tohono O'odham Nursing Care**  
16 **Authority Board (Article IV §(4.2.3); and**

17 **WHEREAS, the Chairman of the Nation has researched, identified and determined that Ms.**  
18 **Malinda Folson is both willing and qualified to continue to serve as one of the**  
19 **Directors to the Tohono O'odham Nursing Care Authority Board; and**

20 **WHEREAS, the Chairman of the Nation does hereby nominate for reappointment, Ms. Malinda**  
21 **Folson to the Tohono O'odham Nursing Care Authority Board, whose term expired**  
22 **October 30, 2009 (Resolution No. 06-141); and**

23 **WHEREAS, the Legislative Health & Human Services Committee and Legislative Rules Committee**  
24 **have both reviewed the Chairman's nomination.**

25 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby accept**  
26 **and approve the confirmation of Ms. Malinda Folson to the Tohono O'odham Nursing**  
27 **Care Authority Board of Directors for a four year term effective October 31, 2009 and**  
28 **ending on October 30, 2013, provided that she shall continue to serve until replaced**  
29 **by her successor.**



5 Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs  
6 (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).


