**RESOLUTION NO. 13-065**

1 **WHEREAS, the Tohono O'odham Legislative Council is vested with the power to enact laws and**  
2 **ordinances governing the enrollment and adoption of members (Article II, Sections**  
3 **1 & 2 and Article VI, Section 1 (h) of the Constitution of the Tohono O'odham Nation);**  
4 **and**

5 **WHEREAS, Articles VI and VII of the Nation's Enrollment Ordinance provide that the Enrollment**  
6 **Committee is responsible for reviewing enrollment applications and making**  
7 **recommendations to the Legislative Council regarding the eligibility of applicants**  
8 **(Ordinance No. 05-81, as amended; 14 T.O.C. Chapter 1); and**

9 **WHEREAS, the Enrollment Program has determined that a number of resolutions approving**  
10 **applicants for membership contain misspellings in the names of applicants and/or**  
11 **incorrect roll numbers; and**

12 **WHEREAS, the Enrollment Program therefore recommends that Resolution Nos. 115-82, 83-83,**  
13 **127-83, 164-83, 222-84, 303-88, 91-235, 92-004, 93-360, 95-518, 96-077, 97-078, 98-123,**  
14 **98-492, 99-200, 2000-003, 04-291, 04-659, 09-85, 10-020 and 13-001 be amended to**  
15 **reflect the correct name spelling or roll numbers for the individuals identified in the**  
16 **Amending Enrollment Resolution List March 2013, which is incorporated by this**  
17 **reference; and**

18 **WHEREAS, the Enrollment Program has further determined that two members were erroneously**  
19 **approved twice for membership (one member was originally approved by Resolution**  
20 **No. 95-319 and one member was originally approved by Resolution No. 2000-397); and**

21 **WHEREAS, the Enrollment Program discovered that these same two members were approved a**  
22 **second time in Resolution Nos. 96-383 and 02-332; and**

23 **WHEREAS, the Enrollment Program therefore recommends that Resolution Nos. 96-383 and 02-**  
24 **332 be amended to delete the members identified in the Amending Enrollment**  
25 **Resolution List March 2013; and**

26 **WHEREAS, the members who were approved in Resolution Nos. 95-319 and 2000-397 will retain**  
27 **the roll numbers and approval dates identified in those original resolutions.**

28 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that Resolution**  
29 **Nos. 115-83, 83-83, 127-83, 164-83, 222-84, 303-88, 91-235, 92-004, 93-360, 95-518, 96-**



9 -0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by Section 1 and  
10 2 of Article II and Section 1 (h) of Article VI of the Constitution of the Tohono O'odham Nation,  
11 adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy  
12 Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act  
13 of June 18, 1934 (48 Stat. 984).


