

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving to add 1 Eligible Minor Member to the Minor Master Listing for the Fourth**  
**Per Capita Payment and Authorizing Distribution of Per Capita Payment and**  
**Interest Income to the Eligible Minor Member)**

**RESOLUTION NO. 13-068**

1 **WHEREAS, on June 28, 1997, the Nation's voters approved Initiative No. IN-01-97, the "Tohono**  
2 **O'odham Voice in the Use of Gaming Revenues" (Initiative"), which authorizes per**  
3 **capita payments to the Nation's members provided that sufficient gaming revenues**  
4 **are available; and**

5 **WHEREAS, the Ordinance for the Regulation of Gaming Activities within the Tohono O'odham**  
6 **Nation ("Gaming Ordinance") was subsequently amended to authorize per capita**  
7 **distribution payments in accordance with the Initiative (Legislative Council**  
8 **Resolution No. 97-303); and**

9 **WHEREAS, the Legislative Council did adopt the Fourth Per Capita Revenue Allocation Plan per**  
10 **Legislative Council Resolution No. 09-164; and**

11 **WHEREAS, the Secretary of the Department of Interior did approve the Fourth Per Capita**  
12 **Revenue Allocation Plan on June 15, 2009; and**

13 **WHEREAS, the Enrollment Program submitted to the Tohono O'odham Legislative Council the**  
14 **Minor Master Listing for eligible minor members for review and approval for the**  
15 **fourth per capita distribution; and**

16 **WHEREAS, pursuant to Resolution No. 09-429, the Tohono O'odham Legislative Council approved**  
17 **the Minor Master Listing, and the initial number of verified eligible minor members**  
18 **for the fourth per capita distribution was 8,664; and**

19 **WHEREAS, the Enrollment Program has identified 1 eligible minor member who was left off the**  
20 **Minor Master Listing for the Fourth Per Capita payment; and**

21 **WHEREAS, the 1 minor member eligible for the fourth per capita did not have the Wells Fargo**  
22 **trust account established in accordance with the Wells Fargo Trust Agreement, which**  
23 **was approved by the Tohono O'odham Legislative Council in Resolution No. 06-258;**  
24 **and**

25 **WHEREAS, the Nation's Treasurer calculated interest due to the eligible minor member for the**  
26 **fourth per capita payment.**

27 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby;**

28 **1. Approves the attached list of 1 eligible minor member whose name was left off**  
29 **the Minor Master List and such name will be incorporated into the Minor Master**



- 2. Authorizes the Office of the Treasurer to transfer \$2,000.00 from the Bank of America Desert Diamond Savings Account to Wells Fargo Bank for the establishment of a minor account pursuant to the terms of the Trust Agreement and Service Agreement approved by Tohono O'odham Legislative Council Resolution No. 06-258.**
  - 3. Authorizes the Office of the Treasurer to transfer \$328.43 from the Bank of America Desert Diamond Savings Account to Wells Fargo Bank to pay the interest income due to the eligible minor member for the fourth per capita.**
  - 4. That any eligible names identified in the future will be added to the Minor Master List subject to approval by the Tohono O'odham Legislative Council.**
  - 5. Authorizes distribution of the fourth per capita payment to the eligible minor member who has reached the age of majority.**
  - 6. Authorizes the distribution of interest income due to the eligible minor member for the fourth per capita payment in the amount of \$328.43.**

**BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Chairman and Vice Chairwoman of the Tohono O'odham Nation are authorized to execute such other documents as may be necessary to implement this resolution.**

**The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 11<sup>TH</sup> Day of MARCH, 2013 at a meeting at which a quorum was present with a vote of 2,780.60 FOR; -0- AGAINST; -0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by Article VI, Section 1 (d)(2) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**
