(Adopting Tohono O'odham Legislative Council Calendar June 2013 - June 2014)

LEGISLATIVE ORDER NO. 13-069

1	WHEREAS,the Tohono O'odham Legislative Council is vested with the power to "establish rules
2	and procedures to regulate all meetings of the Tohono O'odham Council" pursuant to
3	Section 1(a) of Article VI of the Constitution of the Tohono O'odham Nation; and
4	WHEREAS,the Legislative Council has adopted Legislative Rules requiring that
5	Prior to an official adjournment, the Legislative Council shall adopt a legislative
6	calendar which shall commence on the first working day of June on which the
7	Legislative Council shall be called into legislative session; provided that, in a
8	general election year, the legislative calendar shall commence on the first Monday
9	in June that is at least ten days after the Election Board is required to issue its
10	Certificate of Election Results" (Legislative Rules of the Tohono O'odham
11	Legislative Council, Article I, Section 1(A)(1)); and
12	WHEREAS, the Uniform Election Ordinance provides the Nation's voters with the opportunity to
13	contest election results following the Election Board's certification, and it is in the
14	Nation's best interest to adopt a Legislative Council calendar that provides sufficient
15	time to decide election contests before the Council convenes in general session to
16	issue successful candidates certificates of elections (Uniform Election Ordinance,
17	Article VIII); and
18	WHEREAS, in accordance with the calendar provisions of the Legislative Rules, the Rules
19	Committee has developed a "Tohono O'odham Legislative Council Calendar June 2013
20	– June 2014" and recommends its adoption.
21	NOW, THEREFORE, BE IT ORDERED by the Tohono O'odham Legislative Council that,
22	notwithstanding Legislative Rules, Article I, Section 1, the Legislative Council adopts
23	the attached "Tohono O'odham Legislative Council Calendar June 2013 - June 2014."
