

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving Carry Forward Budget for Child Care & Development Fund-Mandatory  
Funds from Grant Year 2012)**

**RESOLUTION NO. 13-075**

1 **WHEREAS, the Tohono O'odham Nation is operating the Division of Early Childhood Development**  
2 **for its young members and providing for their welfare through various programs and**  
3 **services designed to meet their special needs; and**

4 **WHEREAS, the Department of Health and Human Services, Administration for Children and**  
5 **Families has awarded the Tohono O'odham Nation the Child Care & Development**  
6 **Fund for Grant Year 2012 to implement Child Care Services through the Division of**  
7 **Early Childhood Development; and**

8 **WHEREAS, the Child Care & Development Fund is a multi-year grant in which Grant Year 2012**  
9 **Carry Forward Mandatory Funds will be obligated by September 30, 2013 and**  
10 **liquidated by September 30, 2013; and**

11 **WHEREAS, the Carry Forward Budget for Child Care & Development Fund-Mandatory Funds in the**  
12 **amount of \$42,622.15 with an Indirect Cost of 18.43%; and**

13 **WHEREAS, the Human Resources Development Committee and the Budget and Finance**  
14 **Committee of the Legislative Council have reviewed this Budget and recommend its**  
15 **approval and adoption.**

16 **NOW, THEREFORE, BE IT RESOLVED THAT the Tohono O'odham Legislative Council does hereby**  
17 **approve the Carry Forward Budget for Child Care & Development Fund-Mandatory**  
18 **Funds from Grant Year 2012 in the amount of \$42,622.15 with an 18.43% Indirect Cost.**

19 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**  
20 **Chairperson and any designated official to expend and administer the budget as**  
21 **attached, provided that any amendment affecting the funds or funding level is**  
22 **submitted for further prior approval by the Tohono O'odham Legislative Council.**

23 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 11<sup>TH</sup> Day**  
24 **of MARCH, 2013 at a meeting at which a quorum was present with a vote of 2,780.60 FOR; -0-**  
25 **AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by Article**  
26 **VI, Section 1 (d)(2)(3) and (f) of the Constitution of the Tohono O'odham Nation, adopted by the**  
27 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
28 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
29 **18, 1934 (48 Stat. 984).**
