LEGISLATIVE ORDER NO. 13-076

6	the authority to "by majority vote, call for a special session" (Legislative Rules of the
7	Tohono O'odham Legislative Council, Article I, Section 1.D.1.); and
8	WHEREAS, the Housing Committee has requested a special session on March 25, 2013 for the
9	Tohono O'odham Ki:Ki Association 2013 Indian Housing Plan and 2012 audit report.
10	NOW, THEREFORE, BE IT ORDERED that the Tohono O'odham Legislative Council hereby sets a
11	special session on March 25, 2013 for the Tohono O'odham Ki:Ki Association 2013
12	Indian Housing Plan and 2012 audit report.
