## RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL (Approving the Gu Achi District Fiscal Year 2013 Tower User Fees Budget of \$32,262.48)

RESOLUTION NO. 13-079

1	WHEREAS, the Tohono O'odham Legislative Council did convene on March 13, 2013 to address
2	issues pertaining to the Nation; and
3	WHEREAS, on February 23, 2013 at a regular scheduled meeting, Gu Achi District Council passed
4	Resolution #1302-379, approving the Gu Achi District Fiscal Year 2013 Tower User Fee
5	Budget of \$32,262.48; and
6	WHEREAS, the Tohono O'odham Nation Legislative Council passed Resolution #08-586 "Approving
7	a Management Agreement Between the Tohono O'odham Nation, Gu Achi District and
8	the Tohono O'odham Utility Authority for Jewek Mountain"; and
9	WHEREAS, as stated in Legislative Resolution #08-586 that "the Nation, Gu Achi District (the
10	"District") and TOUA have negotiated a Management Agreement that allows and
11	directs TOUA to manage the telecommunications facilities on the top of Jewek
12	Mountain on behalf of the Nation and the District, and allows the Nation and the
13	District to obtain a steam of revenue from TOUA's leasing of space on the transmission
14	tower and the associated equipment building."; and
15	WHEREAS, the Gu Achi District has created a budget in the amount of \$32,262.48 from revenue of
16	the tower user fees; and
17	WHEREAS, the members of the District's Finance reviewed the Fiscal Year 2013 tower user fees
18	budget and have forward their recommendations to the members of the District
19	Council.
20	NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby
21	approve the Gu Achi District Fiscal Year 2013 Tower User Fees Budget of \$32,262.48 as
22	attached hereto.
23	BE IT FINALLY RESOLVED that the Gu Achi District reserves the right to modify its Fiscal Year
24	2013 tower user fees budget according to the Tohono O'odham Nation's process, but
25	any amendments affecting the funds or funding levels shall be approved by the
26	Tohono O'odham Legislative Council.
27 28	The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 13 <sup>TH</sup> Day
29	of MARCH, 2013 at a meeting at which a quorum was present with a vote of 2,780.60 FOR; -0- AGAINST; -0- NOT VOTING; and -0- ABSENT, pursuant to the powers vested in the Council by Article
30 31	11, Section 1 (1)(1) & (2)(1) the Constitution of the Tohono Olodham Nation adams at 1, 41, 77, 1
