(Setting April 9, 2013 Special Session to Attend Oral Arguments in United States District Court for the District of Arizona in *Arizona v. Tohono O'odham Nation*)

LEGISLATIVE ORDER NO. 13-080

1	WHEREAS, the Legislative Council is vested with the power "to establish rules and procedures to
2	regulate all meetings of the Tohono O'odham Council, standing committees, boards
3	and special committees." (Constitution of the Tohono O'odham Nation, Article VI,
4	Section 1(a)); and
5	WHEREAS, the Legislative Rules of the TohonoO'odhamLegislativeCouncilveststheCouncilwith
6	the authority to "by majority vote, call for a special session" (Legislative Rules of the
7	Tohono O'odham Legislative Council, Article I, Section 1.D.1.); and
8	WHEREAS, Article I, Section 2.,(C) of the Legislative Rules of the Tohono O'odham Legislative
9	Council, as amended, provides that "[a]ll Legislative Council sessions shall be held at
10	the Tohono O'odham Legislative Council chambers located in Sells, Tohono O'odham
11	Nation, with the following exceptions [a] majority of all the legislative
12	representatives may vote to hold a session in some location other than the chambers
13	located at Sells."; and
14	WHEREAS, the Commerce Committee has requested a special session on April 9, 2013 in Phoenix,
15	Arizona for the Legislative Council to attend oral arguments in United States District
16	Court for the District of Arizona in the case of Arizona v. Tohono O'odham Nation.
17	NOW, THEREFORE, BE IT ORDERED by the Tohono O'odham Legislative Council that it sets a
18	special session on April 9, 2013 at 11:00 a.m. in Phoenix, Arizona for a legal briefing
19	and to attend 2:00 p.m. oral arguments in the case of Arizona v. Tohono O'odham
20	Nation.
25	The foregoing Order was passed by the Tohono O'odham Legislative Council on the 13 TH day of MARCH, 2013 at a meeting at which a quorum was present with a vote of 2,780.60 FOR; -0-AGAINST; -0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by Article VI, Section 1 (a) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
