

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the Department of Health and Human Services, Division of Family
Assistance – FY2013 Food Distribution Program Budget Modification/Amendment #1
- Account No. 500-13-6331)

RESOLUTION NO. 13-081

1 **WHEREAS, the Department of Health and Human Services is presently operating the Family**
2 **Assistance Division, Food Distribution Program under an FY2013 grant with the United**
3 **States Department of Agriculture (USDA); and**

4 **WHEREAS, by Resolution Number 12-216, the Tohono O'odham Legislative Council approved the**
5 **FY2012 Food Distribution Program budget in the amount of \$240,067.61; and**

6 **WHEREAS, the Department of Health and Human Services, Family Assistance Division has**
7 **prepared the attached FY2013 USDA Food Distribution Program Budget**
8 **Modification/Amendment #1 which increases line item: 7410 R/M Vehicles and**
9 **decreases line items: 7420 R/M Building; and 9000 Indirect Cost from 18.82% to 18.43%;**
10 **and**

11 **WHEREAS, the Health and Human Services committee and the Budget and Finance committee**
12 **have reviewed this budget Modification/Amendment and recommend its approval and**
13 **adoption.**

14 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby**
15 **approve Modification/Amendment #1 which reflects an increase in line items 7410**
16 **R/M Vehicles; and decreases line items 7420 RM Building and 9000 Indirect Cost from**
17 **18.82% to 18.43%.**

18 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**
19 **Chairperson and any designated official to expend and administer the budget as**
20 **attached, provided that that any amendments affecting the funds or funding level**
21 **shall be submitted for further prior approval by the Tohono O'odham Legislative**
22 **Council.**

23 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 13TH Day**
24 **of MARCH, 2013 at a meeting at which a quorum was present with a vote of 2,780.60 FOR; -0-**
25 **AGAINST; -0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by Article**
26 **VI, Section 1 (d)(2)(3) and (f) of the Constitution of the Tohono O'odham Nation, adopted by the**
27 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
28 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
29 **18, 1934 (48 Stat. 984).**






