1 **WHEREAS, the Low Income Home Energy Assistance Program (LIHEAP) services are provided**
2 **through the Arizona Department of Economic Security, Intergovernmental**
3 **Agreement, Contract No.DE111074001; and**

4 **WHEREAS, Amendment No. 4 to the Intergovernmental Agreement has been received, deleting**
5 **and replacing: Terms and Conditions, Background Checks for Employment through**
6 **the Central Registry, section 16.0 and adding section 19.2 regarding confidentiality of**
7 **addresses; and**

8 **WHEREAS, Amendment No. 4 has been reviewed by the Executive Branch Attorney and the**
9 **Nations' Attorney General's office; and**


10 **WHEREAS, the Health and Human Services committee and the Domestic Affairs committee have**
11 **reviewed this contract amendment and recommend its approval and adoption.**

12 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves**
13 **Amendment No. 4 to the Intergovernmental Agreement for the FY2013 LIHEAP**
14 **program for the period beginning July 01, 2012 to June 30, 2013.**

15 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council authorizes the**
16 **Chairperson of the Nation to execute Amendment No. 4 substantially in the form**
17 **attached hereto; provided however that any amendments affecting the contract**
18 **amount shall be submitted for further prior approval by the Tohono O'odham**
19 **Legislative Council.**

20 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 13TH Day**
21 **of MARCH, 2013 at a meeting at which a quorum was present with a vote of 2,780.60 FOR; -0-**
22 **AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by Article**
23 **VI, Section 1 (d)(2)(3) and (f) of the Constitution of the Tohono O'odham Nation, adopted by the**
24 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
25 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
26 **18, 1934 (48 Stat. 984).**
