

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the Title VI A Fiscal Year 2013 Budget Amendment 1, Account #700-13-6221)

RESOLUTION NO. 13-084

1 **WHEREAS, the Tohono O'odham Nation has successfully operated programs for the Elders of the**
2 **Nation; and**

3 **WHEREAS, funding for the operation of the Senior Services Division is possible in part by the Title**
4 **VI of the Older Americans Act of 1978 as amended and administered by the**
5 **Administration of Aging; and**

6 **WHEREAS, by Resolution Number 12-131 the Tohono O'odham Legislative Council approved the**
7 **original FY 2013 Title VI Program budget for \$134,330.00; and**

8 **WHEREAS, the Department of Health and Human Services, Division of Senior Services has**
9 **prepared the attached FY 2013 budget amendment #1 to *decrease* the funds from 6530**
10 **- Transportation; 7100 - Utilities and 7400 - RM Equipment to *increase* funds for 7075**
11 **- Fuel line item and create 7020 - Kitchen Supplies line item; and**

12 **WHEREAS, the IDC rate was adjusted from 18.82% to 18.43% with no change in budget total**
13 **amount; and**

14 **WHEREAS, the Health and Human Services Committee and the Budget and Finance Committee**
15 **of the Legislative Council have reviewed this Budget amendment and recommend its**
16 **approval and adoption.**

17 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby**
18 **approves: the Department of Health and Human Services; Division of Senior Services**
19 **Title VI A FY2013 budget amendment #1; *decreasing* the funds for 6530 -**
20 **Transportation; 7100 - Utilities and 7400 RM Equipment to *increase* funds for 7075 -**
21 **Fuel line item and create 7020 - Kitchen Supplies line item. Also, the adjustment of the**
22 **IDC from 18.82% to 18.43% with no change to the budget total amount.**

23 **BE IT FINALLY RESOLVED that the Tohono O'odham Nation officials to wit, the Chairperson and**
24 **any designated official is hereby authorized to expand the grant, provided however,**
25 **that any amendments affecting the funding or funding levels of the budget shall be**
26 **submitted for further prior approval by the Tohono O'odham Legislative Council.**

27 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 13TH Day**
28 **of MARCH, 2013 at a meeting at which a quorum was present with a vote of 2,780.60 FOR; -0-**
29 **AGAINST; -0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by Article**
30 **VI, Section 1(c)(2) & (j) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono**
31 **O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
32 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
33 **Stat. 984).**




