

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2013 Budget Amendments #1 for Baboquivari District Administration,
Coldfields, and Choulic Communities)

RESOLUTION NO. 13-085

1 WHEREAS, at a regular session of the Tohono O'odham Legislative Council held on March 13,
2 2013; and

3 WHEREAS, Baboquivari District Officials presented amendments to the TOLC Resolution No. 12-
4 452 for FY 2013 budgets to Administration, Coldfields and Choulic Communities; and

5 WHEREAS, the following are the amendments needed for the mentioned budgets:

6 Administration – Correct the account # of 31.13.7000 to 035.13.7000;

7 Line item 6540 Mileage POV – omit language of “covers mileage costs of port-a-jon
8 pump out Services for District Administration”

9 Coldfields – Correct original line item 7350 to 7305 General Liability Insurance

10 Choulic – Correct original line items 6250 Per Diem, 6520 Transportation, 7350
11 General Liability, on spreadsheet to read 6520 Per Diem, 6530 Transportation, and
12 7305 General Liability; and

13 WHEREAS, after review and discussion the Tohono O'odham Legislative Council approves the FY
14 2013 budget amendments #1 for Administration, Coldfields and Choulic.

15 NOW, THEREFORE, BE IT RESOLVED after review and discussion, the Tohono O'odham Legislative
16 Council approved budget amendments #1 for Administration, Coldfields and Choulic
17 Communities as outlined above.

18 BE IT FURTHER RESOLVED the amendments approved will not affect the original FY 2013 budgets
19 of Administration, Coldfields and Choulic Communities, nor will it affect the total
20 original budget of the FY 2013 Baboquivari District of \$1,672,636.70.

21 BE IT FINALLY RESOLVED that any modifications, amendments or changes in the Justifications
22 shall be reviewed and approved by the Budget and Finance Committee and the Tohono
23 O'odham Legislative Council.

24 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 13TH Day
25 of MARCH, 2013 at a meeting at which a quorum was present with a vote of 2,780.60 FOR; -0-
26 AGAINST; -0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by Article
27 VI, Section 1 (d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by the
28 Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant
29 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June
30 18, 1934 (48 Stat. 984).




