14	incorporated herein, increasing the FY 2013 budget from \$1,647,347.60 to
15	\$1,781,756.50 .
16	BE IT FURTHER RESOLVED that identified savings in the amount of \$1,440.00 will be transferred
17	to line item 610-Salaries to cover 2013 minimum wage increase for 50 youth workers
18	and adding FY 2012 surplus funds in the amount of \$100,000.00 to FY 2013 budget.
19	BE IT FURTHER RESOLVED that the following community budget amendments are hereby
20	approved:
21	Williams Community adding FY 2012 surplus funds in the amount of \$15,844.94 to their
22	FY 2013 budget increasing FY 2013 budget from \$20,000.00 to \$35,844.94.
23	Ston Sudagi Community adding FY 2012 surplus funds in the amount of \$6,530.97 to
24	their FY 2013 budget increasing budget from \$20,000.00 to \$26,530.97.
25	Miguel Community adding FY 2012 surplus funds in the amount of \$12,032.99 to their
26	FY 2013 budget from \$40,000.00 to \$52,032.99.
