

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving Chukut Kuk District FY2013 Budget Amendment No. 2)

RESOLUTION NO. 13-087

1 **WHEREAS, the Chukut Kuk District Council did meet on February 23, 2013 at which a quorum was**
2 **present; and**

3 **WHEREAS, Chukut Kuk District FY 2013 Budget Amendment No. 2 was approved by Chukut Kuk**
4 **District Council Resolution No. 2013-23; and**

5 **WHEREAS, the Chukut Kuk District Council did also approve FY 2013 budget amendments for**
6 **Williams Community (Chukut Kuk District Resolution No. 2013-16), Ston Sudagi**
7 **Community (Chukut Kuk District Resolution No. 2013-21) and Miguel Community**
8 **(Chukut Kuk District Resolution No. 2013-22) attached hereto and incorporated in the**
9 **FY 2013 Chukut Kuk District Budget; and**

10 **WHEREAS, Chukut Kuk District FY 2013 Budget Amendment No. 2 has been presented to the**
11 **Legislative Council Budget & Finance Committee for review.**

12 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves**
13 **Chukut Kuk District FY 2013 Budget Amendment No. 2 attached hereto and**
14 **incorporated herein, increasing the FY 2013 budget from \$1,647,347.60 to**
15 **\$1,781,756.50.**

16 **BE IT FURTHER RESOLVED that identified savings in the amount of \$1,440.00 will be transferred**
17 **to line item 610-Salaries to cover 2013 minimum wage increase for 50 youth workers**
18 **and adding FY 2012 surplus funds in the amount of \$100,000.00 to FY 2013 budget.**

19 **BE IT FURTHER RESOLVED that the following community budget amendments are hereby**
20 **approved:**

21 **Williams Community adding FY 2012 surplus funds in the amount of \$15,844.94 to their**
22 **FY 2013 budget increasing FY 2013 budget from \$20,000.00 to \$35,844.94.**

23 **Ston Sudagi Community adding FY 2012 surplus funds in the amount of \$6,530.97 to**
24 **their FY 2013 budget increasing budget from \$20,000.00 to \$26,530.97.**

25 **Miguel Community adding FY 2012 surplus funds in the amount of \$12,032.99 to their**
26 **FY 2013 budget from \$40,000.00 to \$52,032.99.**

5 of MARCH, 2013 at a meeting at which a quorum was present with a vote of 2,780.60 FOR; -0-
6 AGAINST; -0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by Article
7 VI, Section 1 (d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono
8 O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -
9 Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48
10 Stat. 984).


