

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2013 Legislative Branch Budget Modification No. 3/Amendment No. 3)

RESOLUTION NO. 13-088

1 WHEREAS, the Legislative Council is authorized "to manage any funds within the exclusive
2 control of the Tohono O'odham Nation . . . and to appropriate these funds for the
3 benefit of the nation and its members" provided that "[a]ll expenditures of these funds
4 shall be pursuant to appropriations or budgets" authorized by resolution or
5 ordinance (Constitution of the Tohono O'odham Nation, Article VI, Section 1(d)(2)); and

6 WHEREAS, the Legislative Branch FY 2013 budget was approved by Resolution No. 12-209; and

7 WHEREAS, the Legislative Branch administration has prepared and submitted for review and
8 approval its FY 2013 Budget Modification No. 3/Amendment No. 3 in the amount of
9 \$48,500.00 to increase line items 6005-Occasional Appointments by \$1,500.00; 7000-
10 Supplies - Office by \$10,000.00; 7060-Food by \$900.00; 7100-Utilities by \$10,000.00;
11 7110-Communication Expenses by \$8,700.00; 7340-Public Relations by \$8,700.00 and
12 8060-Alterations and Renovations by \$8,700.00; and

13 WHEREAS, the FY 2013 Legislative Branch Budget Modification No. 3/Amendment No. 3 has
14 sufficient funds in the Legislative Branch FY 13 budget to support the proposed
15 Legislative Branch FY 2013 Budget Modification No. 3/Amendment No. 3; and

16 WHEREAS, the Legislative Branch FY 2013 Budget Modification No. 3/Amendment No. 3 has been
17 reviewed by the Budget and Finance Committee & Recommends Approval.

18 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves
19 the FY 2013 Legislative Branch Budget Modification No. 3/Amendment No. 3, Attached
20 hereto.

21 BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham
22 Nation Legislative Council Chairman and Vice-Chairman are authorized to administer
23 the attached budget, provided however, that any amendments affecting these funds
24 or funding levels budgeted shall be submitted for prior approval by the Tohono
25 O'odham Legislative Council.

26 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 13TH Day
27 of MARCH, 2013 at a meeting at which a quorum was present with a vote of 2,780.60 FOR; -0-
28 AGAINST; -0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by Article
29 VI, Section 1 (d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono
30 O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -
31 Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48
32 Stat. 984).




