

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the Carry-Over of \$67,053.59 from FY2012 to FY2013 Sells District
Mining Royalties & Ki:Ki Association 50/50 Grant)

RESOLUTION NO. 13-091

1 **WHEREAS, the Tohono O'odham Legislative Council Resolution No. 11-486 approved the Equal**
2 **Distribution of \$1,371,336.58 of Mining Royalties including Prior Interest in the**
3 **amount of \$80,334.94 to the eleven Districts of the Tohono O'odham Nation; and**

4 **WHEREAS, Sells District Resolution SD-09-12 approved Sells District's portion of this allocation**
5 **which was \$135,611.81 that was budgeted to cover the past due insurance premiums**
6 **owed to the Nation in the amount of \$22,527.27 and to utilize the remaining amount**
7 **of \$113,084.54 to participate in the 50/50 District Challenge being offered to the**
8 **Districts of the Tohono O'odham Nation by the Tohono O'odham Ki:Ki Association; and**

9 **WHEREAS, Sells District Resolution SD-10-12 authorized to match the full amount of the grant by**
10 **utilizing the balance of the Mining Royalties in the amount of \$113,084.54 and**
11 **supplementing that amount with unused Mining Royalty funds from previous**
12 **allocations by carrying over a total of \$86,915.46 which will be a total amount of**
13 **\$200,000.00 in District funds to match the full grant amount; and**

14 **WHEREAS, the 50/50 Challenge Grant was obligated toward home renovation projects and at the**
15 **end of FY2012 the District still had projects pending that could not be addressed due**
16 **to the fiscal year closing and a new budget would have to be developed to utilize those**
17 **funds in fiscal year 2013; and**

18 **WHEREAS, Sells District Resolution SD-23-13 approved the attached budget and its justification**
19 **to address the pending projects and to complete the 50/50 Challenge Grant.**

20 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
21 **Carry-Over of \$67,053.59 from FY2012 to FY2013 Sells District Mining Royalties & Ki:Ki**
22 **Association 50/50 Grant and authorizes the attached budgets and justifications.**

23 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the Sells**
24 **District Chairperson and any designated official to expend and administer the budget**
25 **according to its justification, as attached, provided that any**
26 **modifications/amendments affecting the funds or funding levels of the budget shall**
27 **be submitted for further prior approval by the Tohono O'odham Legislative Council.**




