1	WHEREAS, the Legislative Council is authorized "to manage any funds within the exclusive
2	control of the Tohono O'odham Nation and to appropriate these funds for the
3	$be {\tt nefit} of the {\tt nation} {\tt and} its {\tt members}" provided that ``[a] ll expenditures of these funds$
4	shall be pursuant to appropriations or budgets" authorized by resolution or ordinance
5	(Constitution of the Tohono O'odham Nation, Article VI, Section l(d)(2); and
6	WHEREAS, the Legislative Council appointed a delegation ("Nation's Delegation") to explore
7	economic development projects; and
8	WHEREAS, by Resolution No. 12-208, the Legislative Council passed an Economic Development
9	Budget as part of the Executive Branch Fiscal Year 2013 Tribal Budget; and
10	WHEREAS, the Legislative Council has been briefed on additional actions that are necessary to
11	promote economic development and has developed Amendment No.1 to the Economic
12	Development Budget for that purpose; and
13	WHEREAS, the Nation's Chairman is authorized to administer the Economic Development Budget
14	in consultation with the other members of the Nation's Delegation; and
15	WHEREAS, Budget and Finance Committee of the Legislative Council has reviewed Budget
16	Amendment No.1 and recommends its approval and adoption.
17	NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby
18	appropriates \$900,000.00 from the General Fund Surplus for Amendment No.1 to the
19	Economic Development Budget which is hereby approved for a one time funding.
20	BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the
21	Chairperson and any designated official to expend and administer the budget as
22	attached, provided that any amendments affecting the funds or funding level is
23	submitted for further prior approval by the Tohono O'odham Legislative Council.
