

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the Fiscal Year 2013 San Xavier Allottees Association Budget and
Expenditure of SAWRSA Amendments 9B Farm Cashout Funds)

RESOLUTION NO. 13-097

1 **WHEREAS, the 2004 Southern Arizona Water Rights Settlement Act (SAWRSA) Amendments, P. L.**
2 **108-451, authorized the San Xavier District Council to elect to receive \$18.3 million in**
3 **lieu of the federal government's obligation to construct the proposed 9B Farm on the**
4 **San Xavier Indian Reservation (SAWRSA Amendments Section 304(c)(3)(A)(ii)); and**

5 **WHEREAS, the San Xavier District elected to receive the in lieu payment plus interest (9B Farm**
6 **Cashout Fund) (SXDC Resolution #10-09-10); and**

7 **WHEREAS, expenditures from the San Xavier 9B Farm Cashout Fund must be authorized and**
8 **approved by the San Xavier District Council and the Tohono O'odham Legislative**
9 **Council (SAWRSA Amendments Section 304(f)(1)(B)(i) and (ii)); and**

10 **WHEREAS, the San Xavier District Council approved a three-year funding from the 9B Farm**
11 **Cashout Fund totaling \$844,270.00 to fund San Xavier Allottees Association (SXAA) FY**
12 **2011 through FY 2013 activities and programs (SXDC Resolution #12-10-12); and**

13 **WHEREAS, the SXAA goals are to assist and educate landowners on the San Xavier Indian**
14 **Reservation with respect to allotment related concerns and issues; and**

15 **WHEREAS, SXAA activities accomplished to-date under this grant are: an office has been**
16 **established to meet the on-going needs of the allottees, and the estate planning and**
17 **will writing program has been initiated and is in effect; and**

18 **WHEREAS, in FY 2013 the following projects will also continue: an allottee handbook, workshops**
19 **on land use and economic development, and administration of the Alvarez**
20 **Groundwater Settlement Fund; and**

21 **WHEREAS, the San Xavier District Council has approved the SXAA Fiscal Year 2013 Budget, in the**
22 **amount of \$271,660.00 from the 9B Farm Cashout Fund (SXDC Resolution # 01-13-03);**
23 **and**

24 **WHEREAS, the above-mentioned amount is the third year budget allocation from the Fund; and**

25 **WHEREAS, the Budget and Finance Committee has reviewed the SXAA Fiscal Year 2013 Budget.**

26 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council, in accordance**
27 **with the SAWRSA Amendments and the Nation's Constitution hereby 1) approves the**
28 **Fiscal Year 2013 SXAA Budget in the amount of \$271,660.00 from the SAWRSA 9B Farm**
29 **Cashout Funds, provided that any change in funding purpose or amounts must be**

1 authorized by San Xavier District Council resolution and approved by the Legislative
2 Council, and 2) approves the expenditure by the SXAA of \$271,660.00 in accordance
3 with the FY 2013 Budget for fiscal year 2013 only, provided that the expenditure of 9B
4 Farm Funds and related budgets for subsequent fiscal years must be authorized by the
5 San Xavier District Council resolution and approved by the Legislative Council.

6 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 15TH Day
7 of MARCH, 2013 at a meeting at which a quorum was present with a vote of 2,780.60 FOR; -0-
8 AGAINST; -0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by Article
9 VI, Section 1 (d)(f)(j) and (1) and Section 7 of Article IX of the Constitution of the Tohono O'odham
10 Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting
11 Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16
12 of the Act of June 18, 1934 (48 Stat. 984).
