

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the Sells District Administration FY2013 Budget Amendment #2)**

RESOLUTION NO. 13-100

1 **WHEREAS, Tohono O'odham Legislative Council Resolution No. 12-320 approved the Sells District**
2 **Administration Budget in the amount of \$1,202,479.84 from the Tohono O'odham**
3 **Nation's Gaming Revenue; and**

4 **WHEREAS, Sells District Council Resolution #SD-78-12 and Tohono O'odham Legislative Council**
5 **Resolution #12-355 approved Amendment #1 that allocated the FY2013 Sells**
6 **Community Budget and Justification in the amount of \$75,000.00; and**

7 **WHEREAS, at the beginning of fiscal year 2013 each community was required to begin the year**
8 **with a \$75,000.00 budget with the option to request additional funding if the**
9 **community justified the need; and**

10 **WHEREAS, Sells Community has expended almost 50% of their budget and have requested**
11 **additional funding in the amount of \$63,000 with the attached budget and justification**
12 **which was approved by Sells Community Resolution SC-075-13 and Sells District**
13 **Council Resolution SD-09-13; and**

14 **WHEREAS, Sells District Administration has also identified needs that will require additional**
15 **funding and has prepared the attached Amendment #2 to the overall District budget**
16 **to be increased by \$247,277.90 which was approved by Sells District Council Resolution**
17 **SD-22-13; and**

18 **WHEREAS, the increases for Sells Community in the amount of \$63,000.00 and the Administration**
19 **in the amount of \$247,277.90 will be funded by a carryover of unexpended funds from**
20 **Fiscal Year 2012 in the amount of \$310,277.90; and**

21 **WHEREAS, Amendment #2 will change the overall budgeted amount for the Sells District**
22 **Administration & Communities from \$1,202,479.84 to a new total amount of**
23 **\$1,512,757.74.**

24 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves**
25 **the FY 2013 Sells District Administration & Communities Budget Amendment #2 to**
26 **increase Sells Community FY2013 budget in the amount of \$63,000.00 for a new total**
27 **Sells Community budget of \$138,000.00.**

28 **BE IT FURTHER RESOLVED that this amendment will increase the Sells District Administration**
29 **budget in the amount of \$247,277.90 for a new total for Sells District Administration**
30 **of \$1,149,757.74 for an overall Sells District & Communities Budget of \$1,512,757.74.**



1 **BE IT FINALLY RESOLVED** that the Tohono O'odham Legislative Council hereby authorizes the Sells
2 **District Chairperson and any designated official to expend and administer the budget**
3 **according to its justification, as attached, provided that any modifications or**
4 **amendments affecting the funds or funding levels of the budget shall be submitted for**
5 **further prior approval by the Tohono O'odham Legislative Council.**

6 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 15TH Day**
7 **of MARCH, 2013 at a meeting at which a quorum was present with a vote of 2,780.60 FOR; -0-**
8 **AGAINST; -0- NOT VOTING; and -0- ABSENT, pursuant to the powers vested in the Council by Article**
9 **VI, Section 1 (d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by the**
10 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
11 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
12 **18, 1934 (48 Stat. 984).**






