

**LEGISLATIVE ORDER OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Setting March 28, 2013 Special Session to Consider Agreements for DHS Forward  
Operating Base in Pisinemo District )**

**LEGISLATIVE ORDER NO. 13-108**

1 **WHEREAS, the Legislative Council is vested with the power “to establish rules and procedures to**  
2 **regulate all meetings of the Tohono O’odham Council, standing committees, boards**  
3 **and special committees.” (Constitution of the Tohono O’odham Nation, Article**  
4 **VI,Section 1(a)); and**

5 **WHEREAS, the Legislative Rules of the Tohono O’odham Legislative Council vests the Council with**  
6 **the authority to “by majority vote, call for a special session” (Legislative Rules of the**  
7 **Tohono O’odham Legislative Council, Article I, Section 1.D.1); and**

8 **WHEREAS, the Domestic Affairs Committee has requested a special session on March 28, 2013 to**  
9 **consider agreements for DHS Forward Operating Base in Pisinemo District.**

10 **NOW, THEREFORE, BE IT ORDERED by the Tohono O’odham Legislative Council that it sets a**  
11 **special session on March 28,2103 to consider agreements for DHS Forward Oprating**  
12 **Base in Pisinemo District.**

13 **The foregoing Order was passed by the Tohono O’odham Legislative Council on the 25<sup>TH</sup> day of**  
14 **MARCH, 2013 at a meeting at which a quorum was present with a vote of 2,446.25 FOR; 334.35**  
15 **AGAINST; [01] NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the Council by**  
16 **Article VI, Section 1 (a) of the Constitution of the Tohono O’odham Nation, adopted by the Tohono**  
17 **O’odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**  
18 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**  
19 **Stat. 984).**
