1 **WHEREAS, the Tohono O'odham has operated programs for the Elders of the Nation; and**
2 **WHEREAS, funding for the operation of the Senior Services Division is possible in part with**
3 **funding from Title VI of the Older Americans Act of 1978 as amended and administered**
4 **by the Administration of Aging; and**
5 **WHEREAS, the Senior Services Division is requesting approval for the FY 2014 Title VI Part A, Part**
6 **C and Nutrition Services Incentive Program (NSIP) budgets that will cover the third**
7 **year of a three year grant that commenced on April 1, 2011 to March 31, 2014:**

13 **WHEREAS, the Health and Human Services Committee and the Budget and Finance Committee**
14 **of the Legislative Council have reviewed the budgets and recommend its approval and**

16 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it hereby**
17 **approves the FY2014 Title VI Part A \$134,330.00, Title VI Part C \$46,770.00 and the Title**
18 **VI Nutrition Services Incentive (NSIP) \$3,426.00 budgets covering the third year of**
19 **three year grant that commenced April 1, 2011 to March 31, 2014. Also to utilize the**
20 **Nation's Resources pending reimbursement from the Grantor for the continuation of**
21 **the Grant.**

22 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**
23 **Chairperson and any designated official to expend and administer the budget as**
24 **attached, provided that any amendments affecting the funds or funding level is**
25 **submitted for further prior approval by the Tohono O'odham Legislative Council.**
