

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving Fiscal Year 2013 Gu-Vo District Administration Budget Amendment No. 1, Gu-Vo Community Budget Modification No. 2, Ali Chugk Community Budget Amendment No. 1, and Kukatch Community Budget Amendment/Modification No. 2)

RESOLUTION NO. 13-114

1 **WHEREAS, the Gu-Vo District Administration, Gu-Vo Community, Ali Chugk Community, and**
2 **Kukatch Community did submit their Fiscal Year 2013 Budget and Justification along**
3 **with amendments, which was approved with Tohono O'odham Legislative Council**
4 **Resolution No.12-457; and**

5 **WHEREAS, by Gu-Vo District Governing Council Resolution No. GV-13-030, the Gu Vo District**
6 **Council voted to amend and modify the FY 2013 budget for the Administration and its**
7 **three (3) Communities according to the identified needs of the Communities and the**
8 **District, which then was submitted to the Tohono O'odham Legislative Council Budget**
9 **and Finance Committee for review; and**

10 **WHEREAS, the Administration and its three (3) communities did prepare and acquire the proper**
11 **approval of the attached amendments and modifications and its justification; and**

12 **WHEREAS, the Gu-Vo District Administration is to carry forward funds into the Administration's**
13 **Fiscal Year 2013 Budget in the amount of \$120,120.42 from Fiscal Year 2011 with**
14 **Amendment/Modification No. 2, which includes a budget amendment to add line item**
15 **no. 6004-Bonus, an amendment to 6005-Occasional Appointment language to increase**
16 **the number of appointments from two (2) to three (3), and an amendment to 6120-**
17 **Workers Compensation to change the rate to 0.0124 per the budget office with an**
18 **increase in the number of Occasional Appointments from two (2) to (3) three, and other**
19 **budget modifications and amendments to increase funding in assorted line items per**
20 **the attached budget amendment and modification; and**

21 **WHEREAS, the Gu-Vo Community would be modified by increasing 6510-Lodging in the amount**
22 **of \$4,873.72 and 7110-Communication Expense in the amount of \$4,202.00 and**
23 **decreasing 6530-Transportation in the amount of \$2,873.00 and 7615-**
24 **Donation/Contribution in the amount of \$6,202.00 with Modification No. 2 per the**
25 **attached budget modification; and**

26 **WHEREAS, the Ali Chugk Community budget would amend by carrying forward from Fiscal Year**
27 **2012 \$75,973.83 to increase various line items with their budget Amendment No. 1 per**
28 **the attached budget amendment and modification; and**

1 **WHEREAS, the Kukatch Community budget would be amended by carrying forward from Fiscal**
2 **Year 2012 \$24,800.00 to increase various line items, as well as amendments to the**
3 **justification of 7035-Building Material to include repairs for the community church**
4 **and community building; 7060-Food to decrease the amount of holidays celebrated**
5 **and adding San Husi Church Feast; and 7610-Clothing Allowance by decreasing the**
6 **amount of children eligible for assistance to ten (10); with their budget**
7 **Amendment/Modification No. 2 per the attached budget amendment and**
8 **modification.**

9 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it approves**
10 **the Fiscal Year 2013 Gu-Vo District Administration Budget Amendment No. 1, Gu-Vo**
11 **Community Budget Modification No. 2, Ali Chugk Community Budget Amendment No.**
12 **1, and Kukatch Community Budget Amendment/Modification No. 2 as attached and**
13 **as provided in this resolution.**

14 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**
15 **Chairperson and any designated official to expend and administer the budget as**
16 **attached, provided that any amendments affecting the funds or funding levels shall**
17 **be approved by the Tohono O'odham Legislative Council.**

18 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 02ND Day**
19 **of APRIL, 2013 at a meeting at which a quorum was present with a vote of 2,780.60 FOR; -0-**
20 **AGAINST; -0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by Article**
21 **VI, Section 1 (d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by the**
22 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
23 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
24 **18, 1934 (48 Stat. 984).**


