

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Amending Enrollment Resolution List April 2013 Nos. 303-88, 95-319, 95-341, 96-035,  
96-077, 96-514, 97-177, 97-350, 98-294, 2000-343, 02-180 and 03-536 to Correct Names  
of Enrollment Applicants and/or Roll Numbers and Amending Enrollment Resolution  
No. 01-004 to Delete a Member Who Was Approved Twice)**

**RESOLUTION NO. 13-115**

1 **WHEREAS, the Tohono O'odham Legislative Council is vested with the power to enact laws and**  
2 **ordinances governing the enrollment and adoption of members (Article II, Sections**  
3 **1 and 2 and Article VI, Section 1 (h) of the Constitution of the Tohono O'odham Nation);**  
4 **and**

5 **WHEREAS, Articles VI and VII of the Nation's Enrollment Ordinance provide that the Enrollment**  
6 **Committee is responsible for reviewing enrollment applications and making**  
7 **recommendations to the Legislative Council regarding the eligibility of applicants**  
8 **(Ordinance No. 05-81, as amended; 14 T.O.C. Chapter 1); and**

9 **WHEREAS, the Enrollment Program has determined that a number of resolutions approving**  
10 **applicants for membership contain misspellings in the names of applicants; or**  
11 **incorrect roll numbers; and**

12 **WHEREAS, the Enrollment Program therefore recommends that Resolution Nos. 303-88, 95-319,**  
13 **95-341 96-035, 96-077, 96-514, 97-144, 97-350, 98-294, 2000-343, 02-180 and 03-536 be**  
14 **amended to reflect the correct name spelling or roll numbers for the individuals**  
15 **identified in the Amending Enrollment Resolution List April 2013, which is**  
16 **incorporated by this reference; and**

17 **WHEREAS, the Enrollment Program has further determined that a member was erroneously**  
18 **approved twice for membership (member was originally approved by Resolution No.**  
19 **98-294); and**

20 **WHEREAS, the Enrollment Program discovered that this same member was approved a second**  
21 **time in Resolution No. 01-004; and**

22 **WHEREAS, the Enrollment Program therefore recommends that Resolution No. 01-004 be**  
23 **amended to delete the member identified in the Amending Enrollment Resolution List**  
24 **April 2013; and**

25 **WHEREAS, the member who was originally approved in Resolution No. 98-294 will retain the roll**  
26 **number and approval date identified in that original resolution.**

5 Resolution List April 2013.


6 **NOW THEREFORE BE IT FURTHER RESOLVED** by the Tohono O'odham Legislative Council that

10 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 03<sup>rd</sup> Day  
11 of **APRIL, 2013** at a meeting at which a quorum was present with a vote of 2,780.60 FOR; -0-  
12 AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by Article  
13 II, Sections 1 and 2 and Article VI, Section 1 (h) of the Constitution of the Tohono O'odham Nation,  
14 adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy  
15 Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act  
16 of June 18, 1934 (48 Stat. 984).


