

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Authorizing carry forward from fiscal year 2012 to expend the Budget for KOHN
Dedicated Revenue Account 044-13-1071-7340 for fiscal year 2013)

RESOLUTION NO. 13-118

1 **WHEREAS, KOHN is authorized by Resolution 09-554 to set up a Dedicated Revenue Account for**
2 **the deposit of generated revenues including donations and contributions received;**
3 **and**

4 **WHEREAS, all proceeds, net revenues, donations and contributions are restricted to Public**
5 **Relations expenses including monetary donations given to individuals, groups and**
6 **also payment of district profit share pursuant to an executed agreement; and**

7 **WHEREAS, KOHN has received donations and sponsorships, and currently have unexpended**
8 **revenue in the amount of \$5002.00 and has prepared the attached budget to utilize**
9 **these revenues; and**

10 **WHEREAS, it is necessary for KOHN to request approval from the Tohono O'odham Legislative**
11 **Council to expend the amount deposited into the Dedicated Revenue Account 044-13-**
12 **1071-7340 for Public Relations purposes, for FY 2013; and**

13 **WHEREAS, the Cultural Preservation Committee and the Budget and Finance Committee of the**
14 **Legislative Council have reviewed this Budget and recommend its approval and**
15 **adoption.**

16 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves**
17 **and authorizes KOHN to expend the Dedicated Revenue Account 044-13-1071-7340 for**
18 **Public Relations expenses including monetary donations given to individuals, groups**
19 **and also payment going to the Gu-Achi District for profit sharing due to memorandum**
20 **of agreement as provided in the attached budget, for the period of October 1, 2012**
21 **through September 30, 2013.**

22 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**
23 **Chairperson and any designated official to expend and administer the budget as**
24 **attached, provided that any amendment affecting the funds or funding level shall be**
25 **submitted for further prior approval by the Tohono O'odham Legislative Council.**

26 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 03rd Day**
27 **of APRIL, 2013 at a meeting at which a quorum was present with a vote of 2,780.60 FOR; -0-**
28 **AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by Article**
29 **VI, Section 1 (d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by the**
30 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
31 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
32 **18, 1934 (48 Stat. 984).**


