13	WHEREAS, the Cultural Preservation Committee and the Budget and Finance Committee of the
14	Legislative Council have reviewed this Budget and recommend its approval and
15	adoption.
16	NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves
17	and authorizes KOHN to expend the Dedicated Revenue Account 044-13-1071-7340 for

19	and also payment going to the Gu-Achi District for profit sharing due to memorandum
20	of agreement as provided in the attached budget, for the period of October 1, 2012
21	through September 30, 2013.

23	Chairperson and any designated official to expend and administer the budget as
24	attached, provided that any amendment affecting the funds or funding level shall be
