

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Amendment #1 to the Tohono O'odham Nation Fire Department Fiscal Year 2013
General Fund Budget)**

RESOLUTION NO. 13-125

1 **WHEREAS, the Tohono O'odham Legislative Council approved by resolution No. 12-208 which**
2 **included the FY 2013 Department of Public Safety Fire Department tribal budget**
3 **account 001-13-5050; and**

4 **WHEREAS, the Department of Public Safety Fire Department has prepared the attached FY 2013**
5 **Budget Amendment #1; and**

6 **WHEREAS, the Fire Department has determined that an additional Heavy Equipment Mechanic**
7 **is needed to adequately maintain the fleet; and**

8 **WHEREAS, the Fire Department is reclassifying a Firefighter position to a Heavy Equipment**
9 **Mechanic due to the increase of vehicles being added to the fleet; and**

10 **WHEREAS, this amendment #1 will decrease line item 6000 Salaries, 6010 Leave, 6110 FICA and**
11 **6245 Employee PSPRS and increasing line items 6120 Workers Comp, 6240 Employer**
12 **Matching 401K; and**

13 **WHEREAS, there is a reduction to the approved Fire Department Fiscal Year 2013 total budget**
14 **amount; and**

15 **WHEREAS, the Domestic Affairs Committee and the Budget and Finance Committee of the**
16 **Legislative Council have reviewed this Budget and recommend its approval and**
17 **adoption.**

18 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves**
19 **amendment #1 to the Tohono O'odham Nation Fire Departments Fiscal Year 2013**
20 **General Fund Budget:**

- 21 **1. Decreasing Salary line items affected by reclassification of position.**
- 22 **2. Approved the Heavy Equipment Mechanic and freeze a Firefighter position.**
- 23 **3. Increasing line item 6120 Workers Comp and 6240 Employer Matching 401K.**
- 24 **4. Reduces the approved budget amount of \$4,408,183.59 to \$4,407,206.67.**

25 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that it hereby authorizes the**
26 **Chairman and any designated official to expend and administer the budget attached**
27 **hereto, provided that any amendments affecting funds or funding level shall be**
28 **submitted for further prior approval by the Tohono O'odham Legislative Council.**


