1 **WHEREAS, the Tohono O'odham Nation successfully applied for and was awarded a five year**  
2 **Grant from the U.S. Department of Health and Human Services, Centers for Disease**  
3 **Control and Prevention (CDC) grant period June 30, 2012 – June 29, 2017; and**

4 **WHEREAS, the Tohono O'odham Comprehensive Cancer Control Planning will continue**  
5 **implementation of the comprehensive cancer prevention and control plan to address**  
6 **this health risk; and**

7 **WHEREAS, the U.S. Department of Health and Human Services Centers for Disease Control and**  
8 **Prevention (CDC) has issued a Notice of Award on July 03, 2012 awarding grant funding**  
9 **in the amount of \$200,000.00 for the period covering June 30, 2012 through June 29,**  
10 **2013; and**

11 **WHEREAS, Tohono O'odham Comprehensive Cancer Prevention and Control Planning grant**  
12 **program has prepared a FY 2013 Budget to reflect the award amount of \$200,000.00;**  
13 **and**

14 **WHEREAS, the Budget office, Grants & Contracts, Executive, Health and Human Services**  
15 **Committee and Budget & Finance has reviewed and further recommends approval of**  
16 **the attached FY 2013 Budget.**

17 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council accepts and**  
18 **approves the FY 2013 Comprehensive Cancer Prevention and Control Planning Grant**  
19 **No. 1U58DP003905-01 in the amount of \$200,000.00 for the period covering June 30,**  
20 **2012 through June 29, 2013.**

21 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**  
22 **Chairperson and any designated official to expend and administer the Budget as**  
23 **attached, provided that any Amendments affecting the funds or funding level is**  
24 **submitted for further prior approval by the Tohono O'odham Legislative Council.**

25 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 12<sup>TH</sup> Day**  
26 **of APRIL, 2013 at a meeting at which a quorum was present with a vote of 1,890.20 FOR; 475.70**  
27 **AGAINST; 414.70 [05] NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council**  
28 **by Article VI, Section 1 (f) of the Constitution of the Tohono O'odham Nation, adopted by the**  
29 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
30 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
31 **18, 1934 (48 Stat. 984).**
