

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving Amendment/Modification #1 to the FY 2013 Gaming Budget 001-13-1040 changing
the Title of Two Compliance Investigators to Regulatory Investigators)

RESOLUTION NO. 13-129

1 WHEREAS, the Tohono O'odham Legislative Council approved the FY 2013 Gaming Budget in the
2 amount of \$4,651,120.49 with Resolution No. 12-208; and

3 WHEREAS, the Gaming Office has prepared the attached FY 2013 Budget
4 Amendment/Modification #1; and

5 WHEREAS, the Gaming Office is reclassifying two existing positions changing from Compliance
6 Investigator to Regulatory Investigator; and

7 WHEREAS, amendment/modification #1 will adjust line items and does not change the budget
8 amount; and

9 WHEREAS, the Gaming Office has presented this amendment/modification to the Executive Office,
10 Commerce Committee and to the Budget and Finance Committee of the Legislative
11 Council who have reviewed this budget amendment and recommend its approval and
12 adoption.

13 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves
14 the title change of two Compliance Investigators to Regulatory Investigators with no
15 change to the Gaming Office Budget in the amount of \$4,651,120.49.

16 BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the
17 Chairperson and any designated official to expend and administer the budget as
18 attached, provided that any amendments/modifications affecting the funds or funding
19 levels is submitted for further prior approval by the Tohono O'odham Legislative
20 Council.

21 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 12TH Day
22 of APRIL, 2013 at a meeting at which a quorum was present with a vote of 2,780.60 FOR; -0-
23 AGAINST; -0- NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the Council by Article
24 VI, Section 1 (d)(2) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono
25 O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -
26 Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48
27 Stat. 984).
