(Approving Amendment/Modification #1 to the FY 2013 Budget 001-13-2520 for
Reclassification of the Administrative Assistant Position to Office Manager
and to adjust other line items within the Accounting Budget)**

RESOLUTION NO. 13-131

1 **WHEREAS, the Tohono O'odham Legislative Council approved the FY 2013 Accounting Budget 001-**
2 **13-2520, in the amount of \$3,380,202.65 with Resolution No. 12-208; and**

3 **WHEREAS, the Accounting Department is requesting the Tohono O'odham Legislative Council to**
4 **approve reclassification of the position of Administrative Assistant to Office Manager**
5 **and adjusting other line items per the attached Budget; and**

6 **WHEREAS, the Accounting Department has assessed the needed changes to Budget 001-13-2520**
7 **with Amendment/Modification #1 and presented the amendment to the Budget and**
8 **Finance Committee for review and recommend its approval and adoption.**

9 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves**
10 **Amendment/Modification #1 to change the position of Administrative Assistant to**
11 **Office Manager and adjusting line items per the attached Budget, resulting in no**
12 **increase or decrease to the current FY 2013 Budget.**

13 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**
14 **Chairperson and any designated official to expend and administer the budget, as**
15 **attached, provided that any amendments affecting the funds of funding levels of the**
16 **budget shall be submitted for further prior approval by the Tohono O'odham**
17 **Legislative Council.**

18 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 12TH Day**
19 **of APRIL, 2013 at a meeting at which a quorum was present with a vote of 2,780.60 FOR; -0-**
20 **AGAINST; -0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by Article**
21 **VI, Section 1 (d)(2) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono**
22 **O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
23 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
24 **Stat. 984).**


